- If the bank agrees to my request and I have requested a transfer between Vertigo or No Annual Fee credit card products ("Standard Cards"), the transfer will take effect from the date the transfer is processed. I will not be issued with a new card.
- If the bank agrees to my request, and I have requested a transfer between Gold and Standard Cards, I will receive a new credit card with a new credit card number. The transfer will take effect when I activate any new credit card issued on the account.
- I remain liable for any outstanding transaction(s) made on my existing card. Any balance plus any accrued but undebited interest on my existing account will be subject to the new product's Conditions of Use and Fees and Charges.
- Any annual fee payable will be paid at the same time as the fee is paid for my existing credit card account.
- where a new card(s) is/are issued:
 - I will destroy all my existing card(s) (including additional cards) upon receipt of my new card(s)
 - I will need to re-establish any periodical debits on my existing card account to my new card account by notifying those service providers of my changed details
 - If I have an Autopay facility or credit card insurance on my existing card account, it will continue to apply to my credit card account
 - All transactions conducted in the card activation statement cycle will be charged at the interest rate applicable to the new credit card account type. This may include transactions performed on my existing card.
 - I am required to re-register for phone and Internet banking upon activating my card(s)
 - I direct BankSA to replace any additional cards the Bank issued under my existing credit card number with new additional credit cards, in the names of the same additional cardholders, under my new credit card number.
